## Project Nomination Form

### Eligibility

Investment, commercial or industrial building, development or renovation projects located within the Capital Regional District and completed between **June 1, 2009 and May 31, 2010** are eligible for a Commercial Building Award.

### Judging

Each nomination will be judged on the following criteria:

- Is it built in an environmentally sensitive manner?
- Does it complement the surrounding properties and area?
- Is it esthetically pleasing?
- Are there unique architectural features?
- What is the level of finish (choice in construction materials)?
- Does it answer a specific development need within the community?

A panel of judges selected from Victoria's business community will visit each nomination individually, look at the overall exterior design of the project and determine how it fits into the surrounding area. Once all sites have been visited, the judges will decide on the winners.

### Judging Categories

Awards are presented under the categories of Industrial, Commercial and Investment. Further subcategories are developed each year by the judges based on nominations received.

### Project Statement

In 60 words or less, state why your project deserves recognition.

### Special Features

If there are special exterior features of your project that you want to bring to the judges' attention, please list these on the Nomination Form.

### Heritage Renovation

If your project is a 'heritage renovation', please send in a 'before' picture of the building. Also attach a statement of 60 words or less what renovations were made and why.

### Award Winners

Winners will be announced at an awards ceremony in November 2010.
